Overview of LCAP Goal II and District English Learner Advisory Committee and Reclassification of English Language Learners Presented to the Board

To begin the presentation, District English Learner Advisory Committee (DELAC) President, Delia Sanchez Magaña and Vice President, Selene Miranda highlighted the DELAC recommendations to the Board. The DELAC committee monitors and shares information on State policies that affect English Learners as well as advocates for students, ensuring the District is meeting the needs of its English Learners. The DELAC representatives recommended that the Board and District continue and expand programs that promote multilingualism across all school sites, continue to provide interventions and support at the beginning of the school year, especially in 7th and 8th grade, use multiple methods of communication for English Learner Information, and provide more support for parents in navigating the AERIES portal. Dr. Lagozzino, Assistant Superintendent of Educational Services, Priscilla Figueroa, Director of Family Engagement and Migrant Education, Donelle Soto, Director of ELA, Content Literacy and EL Programs, and Stacey De Knikker, Director of Student Support Services & Special Education, provided an overview on LCAP Goal II- English Learner, Foster Youth, and Special Education/English Learner Student Success. They highlighted the progress of EL students and the District's EL monitoring, support programs, resources and intervention programs. An overview of the California Dashboard data for EL's, students with disabilities and foster youth was also presented.
